*<u>Friends of the Library report</u>*: Beth did not attend. Abby shared their bake/book sale is first week of May and they will solicit volunteers from Board to staff tables/shelve/assist with check-out.

## Library Director's Report:

- They extended an offer for a part time associate, and it was accepted. Still waiting FBI clearance. Hope for hire to join April 10<sup>th</sup>
- Circulation and distribution down in Feb. YoY this is on trend. Kids programming and adult programming going strong. Highlights was STEM activity (marshmallow/sticks engineering).
- Library Foundation of Delaware County 2023 Grant Abby thinking of outdoor furniture. Jenn asked about storage in off-season. Money needs to be spent in 2023 so cannot go to larger renovation planned. Jenn suggested sprucing up of activity room, given its frequent usage and dull appearance. Abby to put in grant request and also include outdoor furniture (as separate proposals) and we will see what gets funded. David M signature required on form. Abby will reach out to him
- Volunteers needed PAC Spring Fling activity table. Scott is organizing a craft. Abby will email out signup link

## Committee Reports:

<u>Finance Committee</u>: Sonya reported on P&L, Balance Sheet, and overall financial health. 40k from Friends and the PA State Aide has been deposited into our account. We are still pending borough funds (April).
